## Foster children eligible for K-12 scholarships

Florida has help for schoolchildren who are low-income, in foster care or homeless.

Florida has the nation's largest scholarship program for economically disadvantaged K-12 schoolchildren. This year, it is providing \$4,335 scholarships to roughly 50,000 students in more than 1,300 private schools of their choosing.

These scholarships are targeted for three groups of children – those with household incomes that qualify for free or reduced-price lunch, those in foster care and those who are homeless.

This program, called the Florida Tax Credit Scholarship, was created in 2001 and is funded by corporations that receive a dollar-for-dollar tax credit for their contributions.

This year, companies contributed \$229 million, and next year they are expected to contribute as much as \$286 million. The intent is to provide learning options for disadvantaged children, allowing their parents or guardians to choose schools that might better meet their children's needs.

Step Up For Students is a nonprofit organization that administers the scholarships, and it provides them on a first-come, first-serve basis each new school year.
